It focuses on improving the quality of life by enhancing business and entrepreneurial activity.

## **Community Futures East Parkland**

Community Futures East Parkland is a non-profit organization that operates under the support of Prairies Economic Development Canada. There are 27 Community Futures offices serving all of Alberta excluding Calgary and Edmonton. Each office operates separately and distinctly from each other with their own Boards of Directors.

Our office located in Mirror has been in operation since November 30, 1988, and previously operated as the East Parkland Business Development Corporation.

# What Role Does a Board Member Play?

Board Members provide governance for the organization, represent it in the community, and ultimately accept legal responsibility for it. As a result, they have the principal responsibility for carrying out the organizations mission and strategic objectives. Board Members accomplish their functions through attendance at regular meetings plus participation in the annual general meetings, strategic planning workshop, training, and community events. Meetings typically are held on the second Monday monthly, excluding August.

# What Role does Board member play in the organization Finances?

As a volunteer board member, it is your responsibility to protect the integrity of the organization's finances. This means you must ensure there is adequate finances, and the money is spent responsibly.

# How are Financial Policies set?

Boards of directors set broad financial policies such as identifying where they want the available funding and revenues earned to be allocated. They must first define the mission, establish the goals and objectives for the organization. This ensures money will be allocated to meet those goals. As a board member you are a trustee of the organization's money. However, this does not mean you must pre-approve every expenditure. Rather, you need to know the money was spent effectively, this can be achieved through regular attendance of board meetings and by having a clear understanding of monthly financial reports presented by staff.

# What are the "Legal Responsibility"?

To accept a position on the Community Futures East Parkland Board of Directors is to accept responsibility for its administration, assets, liabilities, contracts, and overall policies. A volunteer Director must fully understand their roles and responsibility

**FUNDS**- A director must be satisfied that an adequate system exists for the control of funds

**WAGES**- A director can be personally liable for unpaid staff wages should the organization become insolvent

**NEGLIGENCE OF STAFF**- Requires that a director is confident there is adequate insurance in place

**DISCLOSURE OF INTEREST**-A director must disclose any conflicts of interest, whether direct or indirect in a proposed contract or transaction

**ASSETS**- A director should be satisfied there is insurance to cover the buildings and equipment of the organization

**DELEGATION**- A director may delegate authority to staff but CANNOT delegate responsibility

**FULFILLING GOVERNMENT REQUIREMENTS**- A director can be liable for non-compliance with government regulations.

# How can risk be mitigated?

To minimize risk, directors should get to know the people involved with the organization; and have a working knowledge of what is "going on" in the organization. Directors should regularly review financial and activity reports, policies regarding employment practices and contracts.

# What about insurance to cover director's liabilities?

Community Futures East Parkland must have insurance to protect Directors against personal liability and all directors should be cognizant of the coverage which their organization has. It is also important to understand what is and is not covered.

By attending board meetings on a regular basis, reading minutes, reports, understanding financials and budget, becoming familiar with the organization's goals, objectives, programs, and projects, directors can reduce or eliminate the possibility of any legal action against the organization or themselves.
